<p style="text-align: center;">APPLICATION OF DOCKAGE RATES</p> <p>(a) Except as otherwise specifically provided in this tariff, dockage charges as defined in Item 01160 shall be assessed against the vessels in all trades at the full dockage rates provided in Item 04130.</p> <p>(b) When a vessel is assessed dockage for a period of 24 hours at a wharf owned or operated by, or under Lease assignment or franchise from the Port, it may use the same or, upon prior approval of the Director of Maritime or his/her designee, any other wharf within the Port during that 24 hour period without further charge, regardless of how often it may leave or return.</p> <p>(c) When a vessel changes its position from an outside to an inside berth, or otherwise changes its status so that it would be liable to pay dockage at a different rate as provided in this tariff, the dockage due under the changed status shall be assessed from the time such change takes effect.</p> <p>(d) Forty percent (40%) of the full dockage rates provided in Item 04130 will apply for:</p> <p style="padding-left: 40px;">(1) Barges, lighters and other vessels berthed off-shore of a vessel that is paying full dockage.</p> <p style="padding-left: 40px;">(2) Barges, lighters and other vessels berthed off-shore of a vessel at a wharf discharging, loading or lying idle.</p> <p style="text-align: center;">(Item 04105 continued on Next Page)</p>	<p>(R) 04105</p>

<p>FREE DOCKAGE</p> <p>Free dockage will be accorded barges, lighters and other vessels when, at the discretion of the Executive Director, conditions may warrant the temporary suspension of applicable dockage charges against:</p> <p>(a) Combat and training vessels (including vessels auxiliary thereto) of the United States or other Federal agencies and similar vessels of another nation; or, any vessels owned or operated by the State of California or any other State as well as vessels engaged solely in research, education or training.</p> <p>(b) Vessels that are engaged exclusively in exhibitions whose sole purpose is the promotion of trade.</p> <p>(Item 04120 continued on Next Page)</p>	04120

<p data-bbox="537 310 846 338">MONTHLY DOCKAGE FEE</p> <p data-bbox="191 373 1255 562">(a) Operators of barges, lighters, tugs and similar vessels normally employed exclusively in daily Inland Waterway movements to and from Port facilities may, upon written application to the Director of Maritime, or his/her designee, on forms provided by the Port, be afforded monthly rates. Such operators are subject to a minimum charge of \$2,100 per month.</p> <p data-bbox="191 594 1255 716">(b) The monthly rate will be calculated based upon the applicable daily dockage rates multiplied by an average number of daily vessel dockings per 30-day period, subject to the following conditions:</p> <p data-bbox="277 751 1255 905">(1) Use of Port facilities under monthly dockage rates shall be subject to all rules and regulations contained in this tariff as well as special conditions which may be specified on MT Form 150, Standard Application Form for Tariff Assignment and Tariff Assignment.</p> <p data-bbox="277 940 1255 1031">(2) Barges, lighters, tugs and similar vessels subject to this rate will be specifically named on the Port's application form.</p> <p data-bbox="191 1066 1255 1220">(c) Such monthly rates shall be revocable at the discretion of the Executive Director.
